INSTRUCTIONS FOR SANDUSKY COUNTY 2024 KENNEL LICENSES:

ORC 955.02 defines a KENNEL as an establishment that keeps, houses, and maintains adult dogs for the purpose of breeding the dogs for a fee or other consideration received through a sale, exchange, or lease and that is not a high volume breeder.

- 1. Complete this form. Be sure the correct kennel owner and street address appear on all applications.
- 2. List the breeds kept, along with the number of males and females over 3 months of age for each breed.
- 3. Enclose a check or money order for the correct fees payable to: Sandusky County Dog Warden. Please do not send cash. **Before January 31**, licensing rate is \$100.00 for the first 5 tags and \$2.00 for each additional tag. After January 31, statutory late penalty increases the licensing rate to \$200.00 for the first 5 tags. If by mail, please include \$1.00 for postage. Your application cannot be processed without the correct fees.
- Please return the application and check or money order. A receipt will be returned to you with your 2024 license tag(s).
