Come to the Office of the Finance Cashier during office hours. Please bring this notice with you to verify owner information, address, and pet description(s) as shown below. Bring a rabies certificate, proof of spaying/neutering, and a copy of your ID/Driver's License (for senior discount).

All dogs four months or older located within the City of Hermosa Beach must be licensed. Licenses are valid October 1st thru September 30th of each year. To avoid penalties, payments must be received by October 31, 2019. Please check the expiration date(s) of the rabies vaccination(s) on file as shown below and provide an updated certificate if it expires prior to 9/30/2020. **Licenses will only be issued for dogs with rabies vaccinations valid through the entire license period.** If your dog is unable to re-vaccinate prior to the end of the license period, please contact Finance Cashier.
