#### **BY MAIL or IN-PERSON**

Complete the application form below, verifying owner information, street address, and pet description(s). Enclose the form in an envelope, including **rabies certificate**, a check or money order for the total payable to **Town of Natick**. Do not send cash. Mail to the Office of the Town Clerk at 13 E Central St, Natick, MA 01760.

All dogs six months or older kept within the Town of Natick must be licensed. Licenses are renewable annually and are valid January 1 through December 31. Licenses will only be issued for dogs with current rabies vaccination. The license fee is waived for residents 70 years of age or older (limit one per household) and for service dogs. Purchased licenses are non-refundable and non-transferable. Tags must be worn by dogs at all times. If your dog should become lost, please contact the Animal Control Officer at 508-647-9500. A late penalty of \$50.00 for registration will be added after March 1st. All households with 5 or more dogs must obtain a special permit and kennel license.
