BY MAIL or DROP OFF

Complete the application form below, verifying owner information, street address, and pet description(s). Enclose the form in an envelope, including rabies certificate, proof of spay / neuter if first registration, and a check for the total payable to **Elko County**. Do not send cash. Mail to the Clerk or drop it off in person at the Clerk's office.

IN PERSON

Come to the Office of the Clerk during office hours. Bring with you rabies certificate, proof of spay / neuter if first registration, and the completed application.

ON-LINE

Purchase or renew licenses online at www.doglicenses.us/NV/Elko using the Account ID and Password below. Credit card payments only. Per license convenience fee applies. Rabies certificate and proof of spay / neuter if first registration are required. These may be mailed, emailed to clerk@elkocountynv.net, or attached to the order during check-out.

All dogs six months or older located within the non-incorporated areas of Elko County must be licensed. Licenses are renewable annually and are valid January 1 thru December 31. Licenses will only be issued for dogs with current rabies vaccination. Purchased licenses are non-refundable and non-transferable. Tags must be worn by dogs at all times. If your dog should become lost, please contact Animal Control at 775-777-7310.
