## IN PERSON OR BY MAIL

- 1. Complete this form. Be sure the correct kennel owner and street address appear on all applications.
- A valid Belmont County, OH Vendor's License is required to obtain a Kennel License.
- List the breeds kept, along with the number of males and females over 3 months of age for each breed.
- Enclose a check or money order for the correct fees payable to: Belmont County Auditor. Please do not send cash. Before January 31, licensing rate is \$70.00 for the first 5 tags and \$1.00 for each additional tag. After January 31, statutory late penalty increases the licensing rate to \$140.00 for the first 5 tags. Your application cannot be processed without the correct fees.
- 5. Please return the application and check or money order in the enclosed return envelope. A receipt will be returned to you with your 2025 license tag(s).

You may purchase the tag(s) in person at the Belmont County Auditor's Office, 101 West Main Street, St. Clairsville, OH 43950 or the Dog Pound, 45244 National Road, St. Clairsville, OH 43950. Please bring the attached form when purchasing tags.
