INSTRUCTIONS FOR CLINTON COUNTY KENNEL LICENSES:

ORC 955.02 defines a KENNEL as an establishment that keeps, houses, and maintains adult dogs for the purpose of breeding the dogs for a fee or other consideration received through a sale, exchange, or lease and that is not a high volume breeder.

IN PERSON OR BY MAIL

- 1. Detach and complete the below application. Be sure to correct any changes to the owner, street address, and pet description(s) on the application. Application must be signed and dated to process.
- 2. List all breeds kept, along with the number of males and females over 3 months of age for each breed.
- 3. Enclose a check or money order for the correct fees payable to the Clinton County Treasurer. DO NOT SEND CASH. Before January 31, licensing rate is \$70.00 for the first 5 tags. After January 31, statutory late penalty increases the licensing rate to \$140.00 for the first five tags.
- 4. Additional tags may be purchased for an additional \$1.00 for kenneled dogs. <u>Per ORC 955.11 Tags to be worn</u> "no owner of a dog, except a dog constantly confined to a registered kennel, shall fail to require the dog to wear, at all times, a valid tag...A dog's failure at any time to wear a valid tag shall...subject any dog found not wearing such tag to impounding, sale, or destruction."
- 5. FOR MAILED APPLICATIONS, enclose an additional \$1.00 for processing per address.
- 6. Upon your completed application and proper payment, your tag(s) and receipts will be mailed back to you promptly.

Tags may be purchased in person at the County Auditor's Office. Please bring the attached form when purchasing tags.

Certificates of registration and registration tags shall be valid only during the CALENDAR YEAR or YEARS for which they are issued. ORC Sec 955.09.
