INSTRUCTIONS FOR GALLIA COUNTY DOG LICENSES:

IT'S THE LAW (ORC 955.01)

All dogs three months of age or older must be licensed. No dog shall be harbored, kept, or owned without displaying a valid registration tag.

(The law applies regardless of whether the dog is kept inside or out.)

- Use this form to register 1 to 5 dogs. If you have more than 5 dogs, please list them on a separate sheet of paper and return it with this form. Ohio law requires a license for every dog more than 3 months old.
- Enclose a check or money order for the correct fees payable to: **Gallia County Auditor. Before January 31**, licensing rate is **\$12.00 per dog**.
After January 31, statutory late penalty increases the licensing rate to **\$24.00 per dog**. Your application cannot be processed without the correct fees.
- Please return the application and check or money order. A receipt will be returned to you with your 2026 license tag(s).
