## INSTRUCTIONS FOR HURON COUNTY DOG LICENSES:

Hurry and renew today before the deadline.

Payment envelope must be postmarked by Jan 31st to avoid the \$16.00 per dog penalty!

### ON-LINE

Register your dog on-line at [www.doglicenses.us/OH/Huron](http://www.doglicenses.us/OH/Huron). Credit card payments only; \$2.00/license processing fee applies. To access your pre-filled form you will need your Account ID and Password listed below.

### BY MAIL

- Complete this form. Be sure the correct owner, street address, and pet description(s) appear on all applications.
- Use this form to register 1 to 5 dogs. If you have more than 5 dogs, please list them on a separate sheet of paper and return it with this form. Ohio law requires a license for every dog more than 3 months old.
- Enclose a check or money order for the correct fees payable to: **Huron County Treasurer**. Please do not send cash. Licensing rate for one year is **\$16.00 per dog** if purchased on or before January 31st. After January 31, statutory late penalty increases the licensing rate to **\$32.00 per dog**. Your application cannot be processed without the correct fees.
- Please return the application, with your check or money order, in the enclosed return envelope. A receipt will be returned to you with your 2017 license tag(s).

### IN PERSON

You may purchase the tag(s) in person at the Huron County Auditor's Office, 12 E. Main St., Suite 300, Norwalk or at Huron County Dog Warden's Office, 130 Shady Lane, Bldg E, Norwalk, or at any of the outposts located throughout the county. All outposts except the Huron County Auditor's office have a \$.75 license processing fee.

Dogs may be registered for a 1 year or 3 year term, or permanently. Complete each line of the application for your dog(s). In particular, choose your "Term" (1 Year, 3 Year or Permanent) and fill in "Fee Paid" based on the fee structure to the right of this paragraph. 3 Year and Permanent License may only be purchased by mail or in person at the Auditor's office. **No Refunds Permitted!**
