INSTRUCTIONS FOR MARION COUNTY KENNEL LICENSES:

ORC 955.02 defines a KENNEL as an establishment that keeps, houses, and maintains adult dogs for the purpose of breeding the dogs for a fee or other consideration received through a sale, exchange, or lease and that is not a high volume breeder.

IN PERSON OR BY MAIL

- 1. Complete the below application. Be sure to correct any changes to the owner, street address, and pet description(s) on the application. Application must be signed and dated to process.
- 2. List all breeds kept, along with the number of males and females over 3 months of age for each breed.
- 3. Enclose a check or money order for the correct fees payable to the Marion County Treasurer. DO NOT SEND CASH. Before February 2, licensing rate is \$100.00 for the first 5 tags. After February 2, statutory late penalty increases the licensing rate to \$200.00 for the first five tags.
- 4. **Additional tags may be purchased for an additional \$1.00 for kenneled dogs.** *Per ORC 955.11 Tags to be worn* "no owner of a dog, except a dog constantly confined to a registered kennel, shall fail to require the dog to wear, at all times, a valid tag...A dog's failure at any time to wear a valid tag shall...subject any dog found not wearing such tag to impounding, sale, or destruction."
- 5. FOR MAILED APPLICATIONS, enclose a self-addressed stamped envelope with 2 stamps on it.
- 6. Upon your completed application and proper payment, your tag(s) and receipts will be mailed back to you promptly.

Tags may be purchased in person at the Marion County Dog Warden's Office at 2252 Richland Road, Marion, OH 43302. Please bring this application when purchasing tags.
