#### INSTRUCTIONS FOR MARION COUNTY DOG LICENSES:

# IT'S THE LAW (ORC 955.01)

All dogs three months of age or older must be licensed. No dog shall be harbored, kept, or owned without displaying a valid registration tag.

(The law applies regardless of whether the dog is kept inside or out.)

# We are not responsible for lost dog tags sent in the mail.

If you no longer own your dog or if it is deceased, please contact The Marion County Auditor's Office to inform us of the change.

#### **ON-LINE**

Register your dog on-line at www.doglicenses.us/OH/Marion. A per license processing fee applies. Please allow up to 3 weeks to receive your tag by mail. To access your pre-filled form you will need your Account ID and Password listed below:

You may purchase the tag(s) in person at The Marion County Auditor's Office at 222 W. Center Street, Marion, OH 43302, or The Marion County Dog Warden Office at 2252 Richland Road, Marion, OH 43302. Please bring this form when purchasing tags.

- 2. Use this form to register 1 to 5 dogs. If you have more than 5 dogs, please list them on a separate sheet of paper and return it with this form.
- 3. Enclose a check or money order for the correct fees payable to The Marion County Treasurer. **DO NOT SEND CASH FOR MAILED APPLICATIONS, Enclose a self-addressed stamped envelope with 2 stamps on the return envelope.**

Proof is required on the initial registration for a discount. To qualify for the discount your dog must be "Spayed/Neutered" with Veterinarian letter referencing spayed/neutered status. FIRST TIME EXEMPTION IS NOT AVAILABLE ONLINE.

Certificates of registration and tags shall be valid only during the CALENDAR YEAR or YEARS for which they are issued. ORC Sec 955.09.
