**INSTRUCTIONS FOR MEDINA COUNTY DOG LICENSES:**

**IT'S THE LAW**  
**(ORC 955.01)**  
 All dogs three months of age or older must be licensed. No dog shall be harbored, kept, or owned without displaying a valid registration tag.  
 (The law applies regardless of whether the dog is kept inside or out.)

**ON-LINE**

Register your dog on-line at [www.medinacountyauditor.org](http://www.medinacountyauditor.org). In the blue menu, click "Licensing". Then click on "Purchase Dog License". Credit card payments only; **a per dog processing fees applies**. To access your pre-filled form, please use your last year's license number listed below. **DUE DATE IS JANUARY 31, 2023**

**BY MAIL**

1. Complete this form. Be sure the correct owner, street address, and pet description(s) appear on this application. Please indicate which license you would like to purchase in the Term box (*1= 1 Year License, 3= 3 Year License, P= Permanent License*).
2. Use this form to register 1 to 5 dogs. If you have more than 5 dogs, please list them on a separate sheet of paper and return it with this form. Ohio law requires a license for every dog more than 3 months of age.
3. If you no longer own the dog(s) please contact our office or mark the no longer owned box below and return the form so we can update our records.
4. **Before January 31st**, licensing rate for a 1 year is **\$14.00 per dog**. **After January 31st**, licensing rate for a 1 year is **\$28.00 per dog**. 3 year and permanent prices are listed on the back of this form. Enclose a check or money order for the correct fees payable to: **Mike Kovack, Auditor**. Please do not send cash. Your application cannot be processed without the correct fees.
5. **Please return the application, check or money order, and a self-addressed stamped envelope in the enclosed return envelope. A receipt will be returned to you with your 2023 license(s).**

Please note that you can only purchase 1 year licenses at these locations. To purchase a 3 year license or permanent license you will have to visit one of the locations listed below.
