**Renewals** – Ohio Law requires all dogs to be licensed each year before Jan 31<sup>st</sup>. After January 31<sup>st</sup> a penalty equal to the license fee will be added to each dog's license.

**Puppies** must be licensed before they turn 4 months old to avoid penalties.

**Licensing Fees** are determined annually by the County Commissioners.

**No Refunds** – All dog tag fees (1 year, 3-year, permanent registration and kennel license fees) are **NON-REFUNDABLE**

**Not Transferable** – Dog Tags cannot be transferred from one dog to another. They are assigned to one specific dog for the registration per specified.

**Duplicate Tags** – Ohio law requires the tag to be on the dog at all time. If the tag becomes damaged or lost, you can get a replacement tag for a \$5.00 fee.

**Transfer of Ownership** – If there is a transfer in ownership of a dog, the dog tag for that dog can be transferred to the new owner for a \$5.00 fee.

**Change of Address** – Always keep a current address and phone number on record at the Auditor's Office. Please call 740-472-0873 if you have a change.

**Correct Amount Due – We no longer will be able to make change. You must have the correct amount.**
