INSTRUCTIONS FOR SANDUSKY COUNTY 2019 KENNEL LICENSES:

ORC 955.02 defines a KENNEL as an establishment that keeps, houses, and maintains adult dogs for the purpose of breeding the dogs for a fee or other consideration received through a sale, exchange, or lease and that is not a high volume breeder.

IN PERSON OR BY MAIL

1. Complete this form. Be sure the correct kennel owner and street address appear on all applications.
2. List the breeds kept, along with the number of males and females over 3 months of age for each breed.
3. Enclose a check or money order for the correct fees payable to: **Sandusky County Dog Warden**. Please do not send cash. **Before January 31**, licensing rate is \$90.00 for the first 5 tags and \$2.00 for each additional tag. **After January 31**, statutory late penalty increases the licensing rate to \$180.00 for the first 5 tags. If by mail, please include \$1.00 for postage. Your application cannot be processed without the correct fees.
4. Please return the application and check or money order. A receipt will be returned to you with your 2019 license tag(s).
