## INSTRUCTIONS FOR SCIOTO COUNTY KENNEL LICENSES:

**IT'S THE LAW**  
(ORC 955.02)  
A kennel owner is a person, partnership, firm, company, or corporation professionally engaged in the business of breeding dogs for sale.

### ON-LINE

Register your dog on-line at [www.doglicenses.us/OH/Scioto](http://www.doglicenses.us/OH/Scioto). Credit card payments only. A processing fee will apply.

### IN PERSON OR BY MAIL

1. Complete this form. Be sure the correct kennel owner and street address appear on all applications.
2. List the breeds kept, along with the number of males and females over 3 months of age for each breed.
3. Enclose a check or money order for the correct fees payable to: **Scioto County Auditor**. Please do not send cash. On or before January 31, licensing rate is \$60.00 for the first 5 tags and \$1.00 for each additional tag. After January 31, statutory late penalty increases the licensing rate to \$120.00 for the first 5 tags. Your application cannot be processed without the correct fees.
4. Send the application and check or money order to: **Scioto County Auditor, 602-7th Street, Rm 103, Portsmouth, OH 45662**. All mail-in requests for dog tags **must include a self-addressed, pre-stamped envelope**.
5. A receipt will be returned to you with your new license tag(s).

Tags may be purchased in person at the County Auditor's Office. Please bring the attached form when purchasing tags.

**NOTE:** By completing this application you are certifying that you are applying for a 2018 Kennel License on behalf of an establishment that keeps, houses, and maintains adult dogs for the purpose of breeding the dogs for a fee or other consideration received through a sale, exchange, or lease transaction in accordance with O.R.C. 955.02. If you do not meet these qualifications, you are ineligible to purchase a Kennel License and you must instead purchase a 1-Year, 3-Year, or Permanent Dog License for each dog.

Certificate of registration and registration tags shall be valid only during the CALENDAR year IN which they are issued, AND DURING THE CALENDAR YEAR OR YEARS FOR WHICH THEY ARE ISSUED. ORC Sec 955.09.
