<u>Renewals</u> - Ohio Law requires all dogs to be licensed each year before January 31^{st} . After January 31^{st} a penalty equal to the license fee will be added to each dog's license.

Puppies must be licensed before they turn 4 months old to avoid penalties.

New Dogs (4 months of age or older) must be licensed within 30 days of acquiring to avoid penalties.

Licensing fees are determined annually by the County Commissioners.

Section 955.22 of the Ohio Revised Code states: "The owner or keeper of every dog shall at all times keep such dog confined upon his premises."

Section 955.10 States: "No owner of a dog (except a dog constantly confined to a registered kennel) shall fail to require the dog to wear, at all times, a valid tag issued in connection to a certificate of registration."

No Refunds – All dog tag fees (1 year, 3 year, permanent registrations and kennel license fees) are NOT refundable!

<u>Not Transferable</u> – Dog tags cannot be transferred from one dog to another. They are assigned to one specific dog for the registration period specified.

Duplicate Tags – Ohio law requires the tag to be on the dog at all times. If the tag becomes damaged or lost, you can get a replacement tag for a \$5.00 fee. *Auditor's Office only*.

Transfer of ownership – If there is a transfer in ownership of a dog, the dog tag for that dog can be transferred to the new owner for a \$5.00 fee. *Auditor's Office only.*

<u>Change of address</u> – Always keep a current address on record at the Auditor's Office. There is no fee for updating an address and this can even be done over the phone and online.

<u>Licensing Agents</u> - Walk in locations-All agents are entitled to collect a .75-cent agent fee per tag. (Multiple year registrations are available at the Auditor's Office & Online.)
