INSTRUCTIONS FOR WASHINGTON COUNTY KENNEL LICENSES:

IT'S THE LAW (ORC 955.02)

A kennel owner is a person, partnership, firm, company, or corporation professionally engaged in the business of breeding dogs for sale.

ON-LINE

Register your dog on-line at www.doglicenses.us/OH/Washington. Credit card payments only. A processing fee will apply.

IN PERSON OR BY MAIL

1. Complete this form. Be sure the correct kennel owner and street address appear on all applications.
2. List the breeds kept, along with the number of males and females over 3 months of age for each breed.
3. Enclose a check or money order for the correct fees payable to: **Washington County Auditor**. Please do not send cash.
On or before January 31, licensing rate is \$125.00 for the first 5 tags and \$1.00 for each additional tag.
After January 31, statutory late penalty increases the licensing rate to \$250.00 for the first 5 tags.
4. Send the application and check or money order to: **Washington County Auditor, 205 Putnam St., Marietta, OH 45750**.
5. A receipt will be returned to you with your new license tag(s).
6. Any dogs not part of the kennel will have to have separate dog tags.

Tags may be purchased in person at the County Auditor's Office. Please bring the attached form when purchasing tags.

Certificate of registration and registration tags shall be valid only during the CALENDAR year IN which they are issued, AND DURING THE CALENDAR YEAR OR YEARS FOR WHICH THEY ARE ISSUED. ORC Sec 955.09.
