**INSTRUCTIONS FOR WASHINGTON COUNTY KENNEL LICENSES:**

**IT'S THE LAW  
(ORC 955.02)**

A kennel owner is a person, partnership, firm, company, or corporation professionally engaged in the business of breeding dogs for sale.

**ON-LINE**

Register your dog on-line at [www.doglicenses.us/OH/Washington](http://www.doglicenses.us/OH/Washington). Credit card payments only. A processing fee and a mailing fee will apply.

**IN PERSON OR BY MAIL**

1. Complete this form. Be sure the correct kennel owner and street address appear on all applications.
2. List the breeds kept, along with the number of males and females over 3 months of age for each breed.
3. Enclose a check or money order for the correct fees payable to: **Washington County Auditor**. Please do not send cash.  
**On or before January 31**, licensing rate is \$80.00 for the first 5 tags and \$1.00 for each additional tag.  
**After January 31**, statutory late penalty increases the licensing rate to \$160.00 for the first 5 tags.
4. Send the application and check or money order to: **Washington County Auditor, 205 Putnam St., Marietta, OH 45750**. All mail-in requests for dog tags **must include a self-addressed, pre-stamped envelope**. Due to the post office's processing procedures for the tags, the self-addressed, pre-stamped envelope **requires two (2) "Forever" stamps**.
5. A receipt will be returned to you with your new license tag(s).

Tags may be purchased in person at the County Auditor's Office. Please bring the attached form when purchasing tags.

Certificate of registration and registration tags shall be valid only during the CALENDAR year IN which they are issued, AND DURING THE CALENDAR YEAR OR YEARS FOR WHICH THEY ARE ISSUED. ORC Sec 955.09.
